Harrold Primary Academy recognises and welcomes its duty under Section 26 of the Counter-Terrorism and Security Act, 2015, in the exercise of its functions, to have due regard to the need to prevent people from being drawn into terrorism.





The Prevent Duty is seen as part of the schools and colleges wider safeguarding obligations.
